ACCOUNT DISCLOSURES

Except as specifically described, the following disclosures apply to all of the accounts. All accounts described in this Truth-In-Savings Disclosure are share accounts.

1. RATE INFORMATION — The annual percentage yield is a percentage rate that reflects the total amount of dividends to be paid on an account based on the dividend rate and frequency of compounding for an annual period. For Regular Savings accounts, the dividend rate and annual percentage yield may change quarterly as determined by the Credit Union's Board of Directors. For all other accounts, the dividend rate and annual percentage yield may change at any time as determined by the Credit Union's Board of Directors. The dividend rates and annual percentage yields are the rates and yields as of the last dividend declaration date that is set forth in the Rate Schedule. IRA Savings and Money Market accounts are tiered rate accounts. The balance ranges and corresponding dividend rates and annual percentage yields applicable to each tier are disclosed in the Rate Schedule. For IRA Savings and Money Market accounts, once a particular range is met, the dividend rate and annual percentage yield for that balance range will apply to the full balance of your account. Prosperity Money Market accounts are tiered rate accounts. The balance ranges and corresponding dividend rates and annual percentage yields applicable to each tier are disclosed in the Rate Schedule. For Prosperity Money Market accounts, each dividend rate will apply only to that portion of the account balance within each balance range.

For Interest Checking accounts, direct deposit is required. If you do not meet the direct deposit requirement during the calendar month your account will be charged a monthly fee as disclosed in the Fee Schedule. However, you will have a grace period of 90 days from account opening to establish direct deposit before your account would be charged a fee.

2. NATURE OF DIVIDENDS — Dividends are paid from current income and available earnings after required transfers to reserves at the end of the dividend period.

3. DIVIDEND COMPOUNDING AND CREDITING — The compounding and crediting frequency of dividends and the dividend period applicable to each account are stated in the Rate Schedule. The dividend period is the period of time at the end of which an account earns dividend credit. The dividend period begins on the first calendar day of the period and ends on the last calendar day of the period.

4. ACCRUAL OF DIVIDENDS — For all earning accounts, dividends will begin to accrue on noncash deposits (e.g. checks) on the business day you make the deposit to your account.

5. BALANCE INFORMATION — To open any account, you must deposit or already have on deposit the minimum required share(s) in any account. Some accounts may have additional minimum opening deposit requirements. The minimum balance requirements applicable to each account are set forth in the Rate Schedule. For Prosperity Money Market accounts, the minimum opening deposit amount must be made with new money to open the account. New money is defined as money that is not currently on deposit in any

account at the credit union. For Regular Savings, Money Market, Prosperity Money Market and Interest Checking accounts, there is a minimum daily balance required to avoid a service fee for the dividend period. If the minimum daily balance requirement is not met during each day of the calendar month, you will be charged a service fee as stated in the Fee Schedule. For Regular Savings, Escrow, and Money Market accounts, there is a minimum daily balance required to earn the annual percentage yield disclosed for the dividend period. If the minimum daily balance requirement is not met each day of the dividend period, you will not earn the stated annual percentage yield. For accounts using the daily balance method as stated in the Rate Schedule, dividends are calculated by applying a daily periodic rate to the principal in the account each day.

6. ACCOUNT LIMITATIONS — For Share Savings, Money Market and Prosperity Money Market accounts, you may make up to six (6) preauthorized, automatic, telephonic, or audio response Telephone or Online Banking transfers to another account of yours or to a third party during any calendar month. Overdraft Protection transfers from your savings account to pay checks clearing from your checking account are included in this limitation. You may make unlimited transfers to any of your Neighbors Credit Union accounts or loans in person, by mail, or at an ATM. You may make unlimited withdrawals to any of your accounts in person, by mail, or at an ATM. However we may refuse or reverse a transfer that exceeds these limitations and may assess fees against, suspend, or close your account. For Christmas Club accounts, the entire balance will be transferred to another account of yours on or after October 1st and the account will remain open. For Y.E.S Club accounts, you may withdraw funds one time per calendar quarter. For Visa Shares accounts, there may be restrictions on withdrawals. Once you have pledged the funds in this account against a credit card, you cannot access the pledged amount until your credit card is closed and your balance has been paid off. Once that occurs, you may close your Visa Shares account and withdraw all of the remaining funds in your account. For Camp Cash accounts, the account will be converted to a Regular Savings account the month you turn 13. For Escrow Savings accounts, you may withdraw funds twice per calendar quarter for car insurance, home owners insurance, property taxes, medical expenses, or large purchases. For Money Market accounts, checks clearing in excess of three (3) per month will be charged a fee as disclosed in the Fee Schedule. For Prosperity Money Market accounts, three (3) check are allow to clear your account per month. If you exceed this limitation, you will be charged a fee as stated in the Fee Schedule. For IRA Savings, Benefits Checking, Simple Checking, and Interest Checking accounts, no account limitations apply.

7. FEES FOR OVERDRAWING ACCOUNTS — Fees for overdrawing your account may be imposed on each check, draft, item, ATM transaction and one-time debit card transaction (if member has consented to overdraft (Courtesy Pay) practices for ATM and one-time debit card transactions), preauthorized automatic debit, telephone initiated withdrawal or any other electronic withdrawal or transfer transaction that is drawn on an insufficient

available account balance. The entire balance in your account may not be available for withdrawal, transfer or paying a check, draft or item. You may consult the Funds Availability Policy Disclosure for information regarding the availability of funds in your account. Fees for overdrawing your account may be imposed for each overdraft, regardless of whether we pay or return the draft, item or transaction. If we have approved an overdraft (Courtesy Pay) practice limit for your account, such fees may reduce your approved limit. Please refer to the Fee Schedule for current fee information.

For ATM and one-time debit card transactions, you must consent to the Credit Union's overdraft (Courtesy Pay) practices in order for the transaction amount to be covered under the plan. Without your consent, the Credit Union may not authorize and pay an overdraft resulting from these types of transactions.

8. MEMBERSHIP — As a condition of membership, you must purchase and maintain the minimum required share(s) as set forth below.
